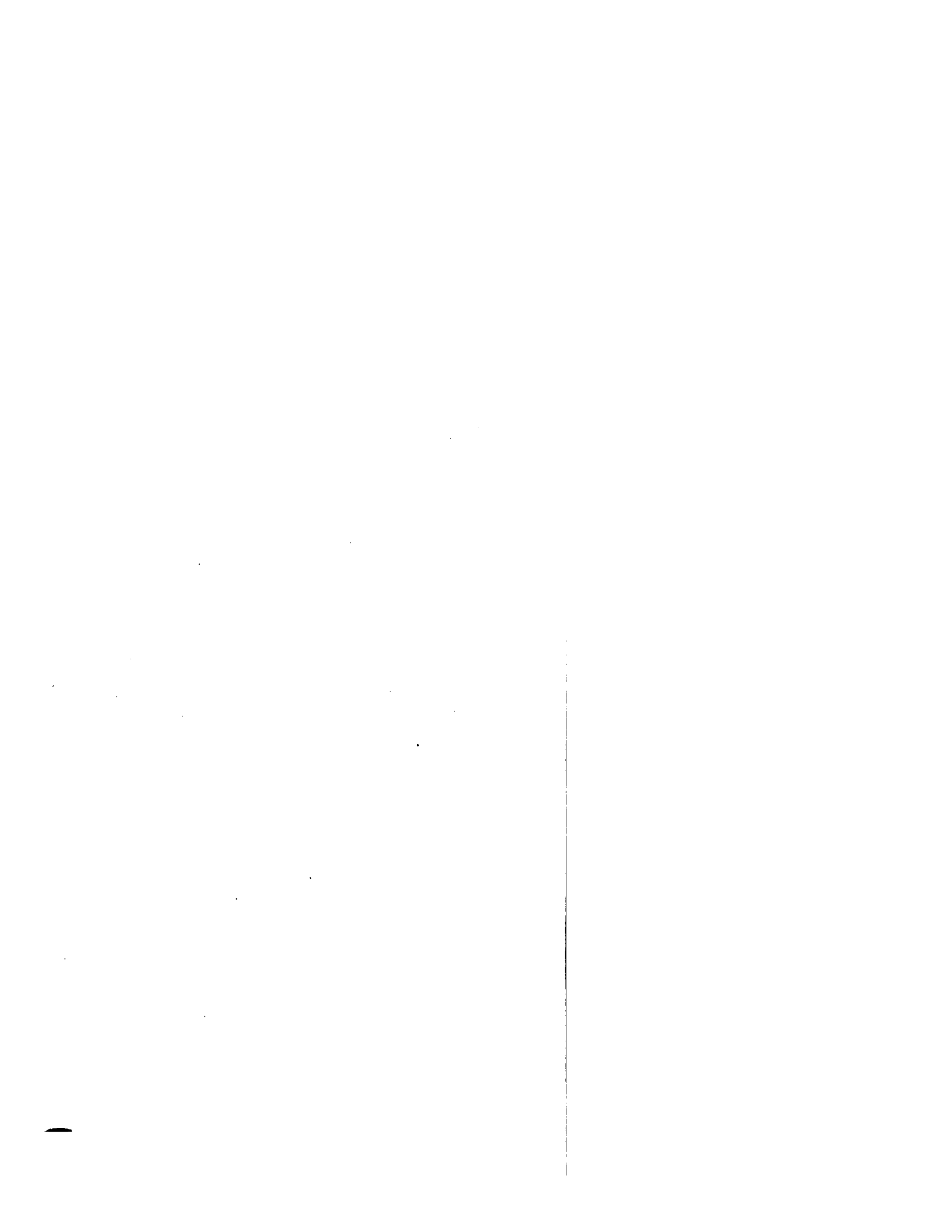
## PREFACE
